NOTIFICATION OF INDEMNITY

I/we, the undersigned, being the parent(s)/guardian(s) of

Hereby indemnify, hold harmless and absolve the Head, employees, leaders or members (hereafter referred to as "The Leadership") chaperoning the children and/or invitees of the said Church, acting in good faith as agents of the Eldership of El Shaddai Christian Church, Durbanville, Cape Town, as well as Base Adventures, against all claims whatsoever as may arise from accident or injury to, or any loss or damage to the property of, the above named child/student, which may occur whilst participating in the Children's Church camp at Gevonden Estate, Rawsonville from 6-8 April 2018 or arising there from or in consequence thereof.

2. The Leadership and Base Adventures will appoint and delegate its powers given to them by virtue of this Agreement to responsible chaperones known to them who will act in *loco parentis* and at all times will exercise such behaviour towards the above named student and exercise such control as is consistent with that of a reasonable parent.

3. No responsibility by the Leadership acting as agents or Base Adventures can be taken for injury and accident which occurs as a result of a breach of Church and/or Base Adventures guidelines, rules and regulations as and where perpetrated by the above named student.

4. I/we the undersigned, agree that in the event of the above named student requiring emergency medical attention which may or may not involve the administration of an anaesthetic and an operation by a suitably qualified medical practitioner/specialist, and in which instance the parents cannot be reached, due permission and authorisation may, in such instances, be given by the Leadership, Base Adventures or any other member of the staff authorised so to do. Such a decision will be made on the clear understanding that the person providing the necessary consent is acting in *loco parentis* and acting as a responsible parent in giving the approval.

5. Notwithstanding the above provisions, approval of this Notification of Indemnity does not in any way remove or deny student or parent(s)/guardian(s) those safeguards which are afforded according to the laws of South Africa, under whose jurisdiction, to the exclusion of all others, this Indemnity pertains.

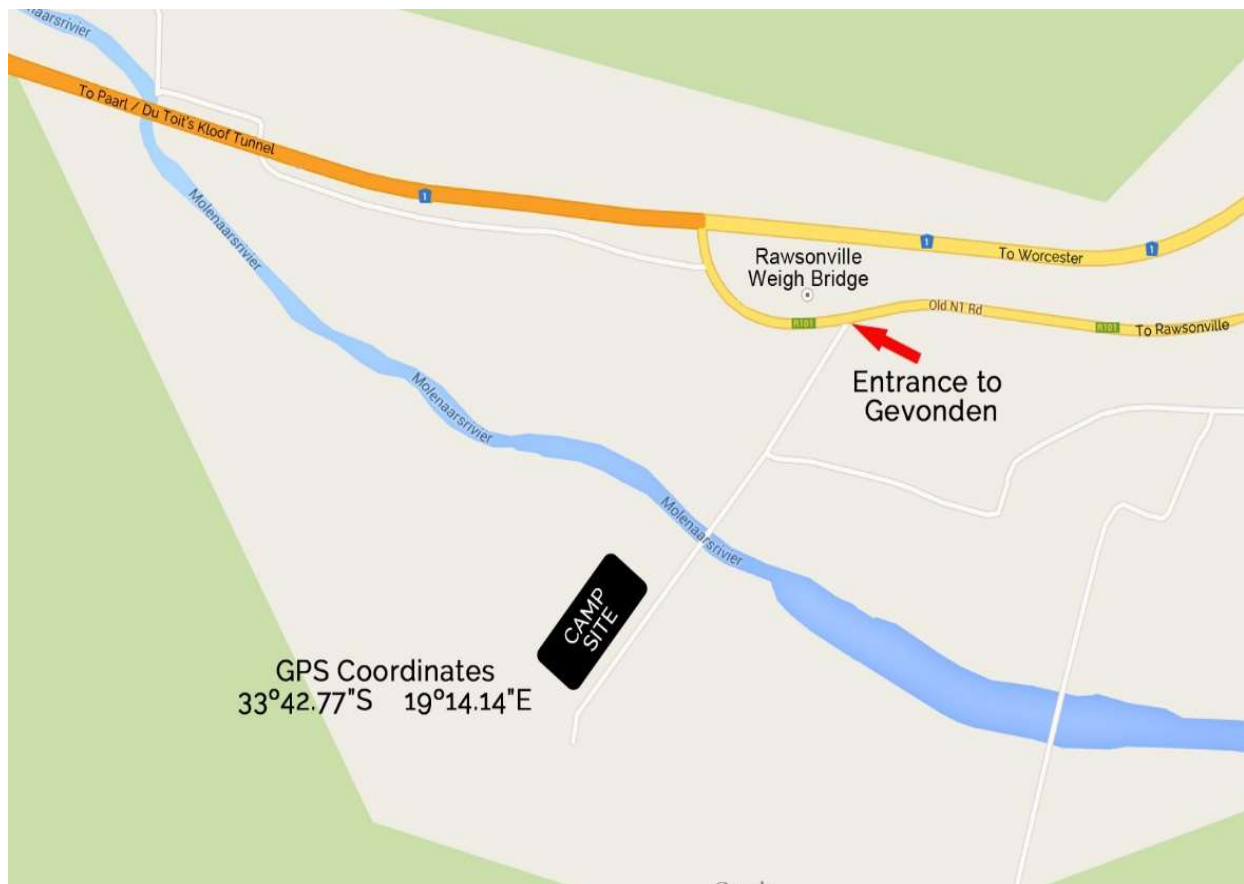
